Dr David K P Li Chairman & Chief Executive The Bank of East Asia, Limited

Dr David K P Li is Chairman & Chief Executive of The Bank of East Asia.

Dr Li has been a prime mover in the development of Hong Kong's financial infrastructure for over 40 years. He represented the Finance Constituency in the Legislative Council of Hong Kong from 1985 to 2012. He is a Director of a number of prominent public companies, both in Hong Kong and overseas.

Dr Li is a strong supporter of educational causes, and is currently the Pro-Chancellor of The University of Hong Kong and Chairman of the INSEAD East Asia Council. He is also the Founder and Chairman of the Friends of Cambridge University in Hong Kong and the Prince Philip Scholarship Scheme.

Among his many commitments to registered charities, Dr Li is Chairman of The Salvation Army Hong Kong and Macau Command Advisory Board, and Chairman of St. James' Settlement.

Dr Li holds a Master's degree in Economics and Law from the University of Cambridge in the United Kingdom. He is a Fellow of the Chartered Institute of Bankers and the Institute of Chartered Accountants in England and Wales.



Mr Julian Chow Group Managing Director Tricor

Mr Julian Chow is Group Managing Director at Tricor. Prior to joining Tricor in 2002, Mr Chow was a Partner at Ernst & Young Hong Kong (EY) and was the Founder and Managing Director of Tengis Limited, a leading provider of corporate, trust and investor services under EY. He has over 35 years of experience in these professional service areas.

Mr Chow is a Chartered Secretary and a Fellow of The Hong Kong Institute of Chartered Secretaries (HKICS) and The Institute of Chartered Secretaries and Administrators (ICSA) in the United Kingdom. Mr Chow was a Council Member of HKICS in the 1990's. Currently, he is an Honorary Council Member of the Hong Kong Committee for UNICEF. Mr Benjamin Tang Former Director of Audit Audit Commission of Hong Kong

Mr Benjamin Tang joined the Hong Kong Government as an Administrative Officer in 1974. He served in various government posts which included working in the Hong Kong Government Office in London in the 1980s and the Independent Commission Against Corruption (ICAC) in the 1990s.

He was appointed by the Central Government as Director of Audit of the HKSAR in 2003 and retired in 2012. Thereafter, he was awarded the Gold Bauhinia Star (GBS).

After completing the Inquiry Into the Collision of Vessels Near Lamma Island in 2012, Mr Tang currently serves as Chairman of the Centennial College Audit Committee and member of the College Council, and also serves as member of the Operations Review Committee of the ICAC and Audit Committee of the Croucher Foundation. He has recently been appointed an Independent Non-executive Director of the MTR Corporation.

Dr Welford has over 20 years of experience working in the fields of environmental management and social responsibility.
